Once your application is received, the applicant will be notified via email that the application has been submitted and then the committee will notify the applicant of the interview.

Grant Selection Process

1. The Father Dennis Mullen Adoption Initiative, Inc (FDMAI) committee meets monthly to review the applications submitted to FDMAI. The committee will then set up times and dates to meet with the applicants.
2. After personal contact, the FDMAI will again review the applications and award the grant.
3. Applicants will be notified of the outcome of their application via US mail within 10 days of the Committee's decision.

Criteria for Applications

A completed application along with the supporting documents must be received. Those that are not completed or do not have the supporting documents will not be considered.

Applicants

Applicants must prove a financial need.

Applications

Applications must not be submitted for reimbursement for an already completed adoption.

Applications will be reviewed by FDMAI committee, then those completed applications that meet all described criteria and exhibit the greatest financial need, significant obstacles, and hardships will be presented to and reviewed by the committee for final selection. The final decision will be on a case-by-case basis.

Please do not call or email to follow-up on your submitted application, unless you are invited to by the FDMAI committee.

Grant monies must be utilized within six (6) months from when the check arrives at the provider, otherwise, the monies will be returned and used for the next funding cycle.

If at any time the recipient terminates their adoption plans, the grant money will be forfeited and returned to the FDMAI.

FDMAI accepts applications regardless of race, religion, ethnicity, or marital status.

FDMAI committee members are not allowed to apply for this grant.
